CTHS seeks a Letter of Approval, also known as a Certificate of Need, from Nevada Health Authority pursuant to Nevada Revised Statutes (NRS) 439A.100. CTHS is proposing for development a comprehensive, 90,000 square foot healthcare facility in South Carson City, Douglas County, Nevada. CTHS estimates capital expenditures of \$81,481,135.00 related to the proposed project. Please see the attached application submitted by CTHS for more information on the proposed project.
