Oncology Consultants, PLLC is proposing to lease and renovate an existing building in Carson City, Nevada to offer a new outpatient cancer center. The official location is to be determined. These are the current properties being considered: 3476 Executive Pointe Way, 1987 Old Hot Springs Rd, 783 Basque Way, 917 Mountain St, Carson City, NV 89703. This facility will include Radiation Oncology, Medical Oncology, Cancer Survivorship Care, Palliative Care, Rheumatology and primary care. Oncology Consultants, PLLC estimates capital expenditures of \$6,633,000.00 related to the proposed project.
