# **Notice of Public Hearing**

NOTICE IS HEREBY GIVEN that the Nevada Health Authority (NVHA) will hold a public hearing on **Tuesday**, **November 25**, **2025**, **beginning at 2:00 PM** Pacific Time (US and Canada) via teleconference to receive comments regarding **South Lyon Medical Center's** application for a Certificate of Need as required by NAC 439A.415. On October 15<sup>th</sup>, 2025, NVHA received and the application for a Letter of Approval, pursuant to NRS 439A.100. The proposed project involves the construction of a new primary care clinic (RHC) to replace the existing modular facility, which has reached the end of its useful life and no longer meets current healthcare delivery standards. The new stick-built clinic will be located within the same service area to ensure uninterrupted access to care for the community it serves.
